<b>Secondary REALTOR®</b>	<ul style="list-style-type: none"> <li>Subject to the payment of MCAR local dues only.</li> <li>National and State dues are paid to and remitted by the members' Association of primary membership.</li> </ul>
<b>Returning REALTOR®</b>	<ul style="list-style-type: none"> <li>Subject to the payment of prorated total dues PLUS a reactivation fee of \$60.</li> <li>Membership renewal following the removal of license from escrow or referral status.</li> </ul>
<b>Transferring REALTOR®</b>	<ul style="list-style-type: none"> <li>Applicant transferring from another local Association is subject to the payment of total prorated dues.</li> <li>MCAR New Applicant Fee and PAR New Applicant Capital Investment Fee are waived for transfers.</li> <li>Mid year transfers are subject to the payment of prorated local dues only provided NAR and PAR dues have been paid to former Association</li> </ul>
(*) Suggested Voluntary RPAC Contribution	<p>RPAC contributions are NOT DEDUCTIBLE for Federal Income Tax purposes. Contributions to RPAC are voluntary and are used for political purposes. Stated amounts are suggested minimum voluntary contributions to the Realtors Political Action Committee. You may refuse to contribute without reprisal or otherwise affecting your membership rights. Seventy percent of your contribution goes to your state association to support state and local political candidates. Thirty percent is sent to National RPAC to support federal candidates against your limits under 2 u.x.c. 441a</p>
